Purpose and Goals

Group Expectations

- Respectful interactions is expected. Personal attacks and offensive language is prohibited.
- Posts should remain relevant to school matters: events, activities, announcements and discussions related to education and wellbeing.
- Advertising of products and services is prohibited unless related to school events and approved by the principal or delegate.
- Privacy is paramount; therefore, no personal information should be shared about themselves or students. Examples include addresses, contact information, use of surnames, student photos or other sensitive information.

Membership and Access

- Parents / guardians / carers of current OAC students.
- To maintain security and privacy new members will be verified against information in DAYMAP.
- Please note that when your child is no longer enrolled, membership will be discontinued.
- The Facebook group is a private group.
- Requests for membership and maintenance of the membership is the responsibility of the Communications and Events manager.

Moderation

Moderation is critical to keeping the group constructive and positive.

- Governing Council will assign 1-2 parent Moderators. Executive leadership will assign 2 members to be moderators. Moderators are individuals who are active, responsible, and committed to maintaining a positive environment.
- The Events and Communication manager will be the key contact for the moderators.
- Posts require approval from a moderator before being visible to the group. This helps prevent spam or inappropriate content.
 - Moderators will act swiftly when rules are violated. Depending on the severity, this may involve issuing a warning, or removing a member from the group.

Administration

- The Communication and Events Manager has full control over group settings, including membership approval and content management.
- The Admin Manager is backup for the CEM.
- The CEM ensures open communication with executive leadership on matters that may arise regarding this group.
